## **RESOLUTION 2023-08**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELLEAIR BEACH, FLORIDA, ESTABLISHING THE FINAL AD VALOREM MILLAGE RATE FOR THE FISCAL YEAR 2023 – 2024 FOR THE CITY OF BELLEAIR BEACH, FLORIDA, AT 2.0394 MILLS AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, the annual estimate of anticipated revenues and expenditures of the City of Belleair Beach, Florida, for the fiscal year commencing October 1, 2023, and ending September 30, 2024, has been submitted by the City Manager in accordance with Article VIII of the City Charter; and

**WHEREAS**, the City Council of the City of Belleair Beach, Florida is required by the City Charter to adopt an annual Operating and Capital Improvement Budget for each fiscal year; and

**WHEREAS**, Section 200.065, Florida Statutes, establishes the method of fixing the millage rate by the governing body of a taxing authority; and

**WHEREAS**, the City Council of the City of Belleair Beach, Pinellas County, Florida, held a public hearing on September 6, 2023, at 6:00 p.m. to adopt a tentative millage rate as required by Florida Statute 200.065; and

**WHEREAS**, the City Council has reviewed the City Manager's proposed budget, amended it and tentatively adopted the amended budget; and

**WHEREAS**, the City Council of the City of Belleair Beach must set the final millage rate for fiscal year 2023-2024 to be used in computing the amount of ad valorem taxes to be raised to fund the final budget; and

**WHEREAS**, the City Council of the City of Belleair Beach, Pinellas County, Florida, held a public hearing on September 18, 2023, at 5:05 p.m. to adopt a final millage rate as required by Florida Statute 200.065; and

**WHEREAS**, City Council of the City of Belleair Beach now deems it necessary, proper and to the best interest of the public to adopt by resolution the final millage rate for fiscal year 2023-2024.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BELLEAIR BEACH, FLORIDA HEREBY RESOLVES:**

1. That the ad valorem tax millage rate for fiscal year 2023-2024 is hereby established at 2.0394 mills.
2. That the millage rate levied is higher than the rolled-back rate of 1.8494 as certified by the County Appraiser on July 1, 2023, and has increased by 10.27%.
3. That this Resolution shall take effect immediately upon final adoption.

## **RESOLUTION 2023-09**

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELLEAIR BEACH, FLORIDA, MAKING APPROPRIATIONS FOR CERTAIN EXPENDITURES, EXPENSES, CAPITAL IMPROVEMENTS AND CERTAIN INDEBTEDNESS OF THE CITY OF BELLEAIR BEACH, FLORIDA FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2023, AND ENDING SEPTEMBER 30, 2024, AND ESTABLISHING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Belleair Beach will begin a new fiscal year on October 1, 2023; and

**WHEREAS**, Section 200.065, Florida Statutes, sets out the method of adopting the budget by the governing body of a taxing authority; and

**WHEREAS**, it is necessary and required that prior to beginning a new fiscal year a budget should be passed and adopted for the operation of the City government; and

**WHEREAS**, the City Council has held the two required public hearings on the proposed budget for the fiscal year beginning October 1, 2023, and ending September 30, 2024; and

**WHEREAS**, by adoption of Resolution 2023-08 the City Council of the City of Belleair Beach established a tax at the rate of 2.0394 mills on property assessed as of January 1, 2023, for the purpose of raising revenue for General Fund Operations; and

**WHEREAS**, the City Council deems approval of this Resolution to be in the best interest of the health, safety, and welfare of the residents and citizens of the City of Belleair Beach, and the public at large.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BELLEAIR BEACH, FLORIDA:**

- Section 1.** That the documents entitled “City of Belleair Beach, Florida, Final Annual Budget Fiscal Year 2023-2024” dated September 18, 2023, comprise the total amount of \$12,998,390.00 for all funds reported.
- Section 2.** The budget is being presented as a balanced budget whereby there are sufficient revenues to offset all estimated expenditures and expenses.
- Section 3.** All budget appropriations are based upon the total expenditure and/or expenses even though the budget has been prepared based on line items and summarized to a categorical level.

- Section 4.** Appropriations may be transferred for the purpose of equalization when needed by a budget transfer with the approval of the City Manager as necessary. This action will not change the total dollar amount of the budget.
- Section 5.** The City Council during fiscal year 2023-2024 may, by Resolution make any amendments to the Budget adopted by this Resolution, as it may deem necessary and proper.
- Section 6.** All Budget Amendments requesting additional expenditures or expenses must also identify the corresponding funding source.
- Section 7.** Cash Balance Reserves shall be carried forward for prior year encumbrances and re-appropriated open purchase orders which will be paid in FY 2023-2024.
- Section 8.** This Resolution shall become effective on and after October 1, 2023.
