Recommendation:

Request City Council authorization to award Bid B18-02 for Drainage Improvements for First Street and Harbor Drive BMP 1 to Caladesi Construction Company in the amount \$318,364.20.

History:

A Master Drainage Plan was completed in 2016 recommending modifications to reduce flooding.

Background:

The project includes storm water pipe extension and replacement, curb replacement and resurfacing of pavement on First Street and a portion of Harbor Drive. Funding is provided in the FY 17/18 Capital Budget. A copy of the bid tabulation is attached for your review
