PUBLIC MEETING MINUTES

The meeting was called to order by Mayor Joseph A. Manzo. Mayor Manzo asked for a moment of silence for the passing of Town of Belleair Mayor Gary Katica, followed by the Pledge of Allegiance to the Flag of the United States of America.


